APPELLEE'S MOTION FOR LEAVE TO FILE AN OVER-LENGTH BRIEF

COMES NOW Appellee/Plaintiff Mohammad Hamed, by and through his undersigned counsel, pursuant to VISCR 22(f) and moves for permission to file 5 extra pages in his brief, for a total of 35 pages. In support of this motion for an over-length filing, he states as follows:

1. Appellants' opposition brief, which is limited to 30 pages by VISCR 22(f), is due to be filed by June 27, 2013.
2. Appellants were granted 35 pages -- and their brief contains 35 pages.
3. There are four issues to be addressed, one of which has multiple sub-parts. The record is also complex: over 450 pages of transcripts and 42 exhibits.
4. After review of Appellants brief and initial drafting, Appellee's draft brief currently exceeds the 30-page limit, with several arguments not yet drafted. Undersigned counsel believes that the Appellee cannot effectively advance Appellee's substantial responses within the page limitation contained in VISCR. 22(f).

For the following reasons, Appellee requests leave to file the brief in excess of the page limitation of VISCR 22(f), so his brief can be 35 pages rather than 30 pages.

WHEREFORE, in the interests of justice, it is respectfully requested that this Court permit the Appellee to file a brief in excess of the page limitations set forth in VISCR 22(f).
