NOTICE TO COURT RE MISSED PAYROLL AND REQUEST FOR ASSISTANCE BY MASTER

The payroll for each of the three Plaza Extra Stores is paid electronically after the Yusuf and Hamed managers approve it. Since the Preliminary Injunction was entered, the weekly payroll has not been a problem. However, this week the payroll for the Plaza East store was not approved by Fathi Yusuf because he wanted to make a unilateral change (without an Order from this Court) by deleting Wally Hamed from the payroll. As such, while the payroll for the other two stores was processed and paid, none of the 200 employees for Plaza East were paid since Fathi Yusuf directed his designated manager, Yusuf Yusuf, not to approve the electronic payroll.

While the Master was just appointed, it is requested that he be assigned to correct this issue immediately, all of which could have been avoided if Fathi Yusuf had

not acted unilaterally in trying to make a management change without complying with the Preliminary Injunction. Yusuf's conduct also needs to be addressed, although paying the employees is more urgent at this juncture.
