MOTION TO SHOW CAUSE

As noted yesterday in a filing with the Court, the payroll for each of the three Plaza Extra Stores is transferred electronically after the Yusuf and Hamed managers approve it. Since the Preliminary Injunction was entered, the weekly payroll has not been a problem.

However, this week the electronic transfer for payroll for the Plaza East store was not approved by Fathi Yusuf because he wanted to make a unilateral change (without an Order from this Court) by deleting Wally Hamed from the payroll. As such, while the payroll for the other two stores was processed and paid, none of the 200 employees for Plaza East were paid through the established electronic payroll.

As Yusuf insisted on unilaterally not paying Waleed Hamed despite this Court's Preliminary Injunction requiring the status quo to be maintained he had checks signed only by 1 person — Fathi or Yusuf Yusuf — individually written to employees which he then admits through his counsel that Plaza Extra Supermarkets was made to cash, even though no Hamed manager had signed the checks (the Hamed manager had already approved the electronic payroll checks). See Exhibit 1 attached.

In short, just like the unilateral removal of funds that started this litigation, Fathi Yusuf has decided he can circumvent this Court's Preliminary Injunction Order as he wishes--without seeking a modification from the Court as required by that Order. Thus, it is respectfully requested that this Court issue a show cause order to Fathi Yusuf to show cause why he should not be held in contempt for violating this Court's Preliminary Injunction (PI) Order by:

- 1) By not processing the electronic payroll as has been done in all three stores for years, thus unilaterally changing the Plaza East store's procedures without a Court Order modifying the PI;
- 2) By cashing payroll checks that had not been signed by any Hamed manager, as expressly directed by this Court in the PI; and
- By not paying Waleed Hamed, again unilaterally bypassing this Court's
 PI Order.

It is respectfully submitted that this Court needs to protect the integrity of the PI Order by issuing a show case Order to Fathi Yusuf. It also respectfully suggested that this Court should inquire as to whether any counsel for the Defendants were involved in the decision to circumvent this Court's PI Order.
