THIS MATTER is before the Court is Appellant's Emergency Motion to Stay Pending Appeal of Portions of the Superior Court Order Adopting Final Wind Up Plan. While the accompanying motion contains numerous citations to Appellees' Opposition to the Motion to Stay filed in the Superior Court, Appellant does not include this Opposition in his exhibits and Exhibit 4 is illegible. The Court will therefore require Appellant to correct these deficiencies and will order Appellees to file an expedited response.¹ Accordingly, the premises considered, it is hereby

ORDERED that, no later than 12:00 p.m. Tuesday, February 17, 2015, Appellant **SHALL FILE** the documents referenced in this Order; and it is further

ORDERED that Appellees **SHALL RESPOND** to Appellant's Emergency Motion for Stay Pending Appeal no later than 12:00 p.m. Wednesday February 18, 2015; and it is further

ORDERED that copies of this Order shall be issued to the parties.

¹ Appellant states that "the disputed provisions of the Plan concerning Plaza Extra-West could be fully implemented by February 18, 2015, thereby impairing this Court's ability to effectively review those provisions on appeal." Brief at 2. However, Appellant cites no portion of the record to support this statement. Moreover, the Court notes that the order appealed was entered on January 9, 2015, but Appellant did not file his notice of appeal until January 28, 2015.


