ORDER AND EXPEDITED BRIEFING SCHEDULE

THIS MATTER comes before this Court pursuant to Appellant's motion to consolidate these appeals, as well as Appellees' opposition. Although Appellant correctly notes that both appeals stem from the same Superior Court proceeding, Appellees request that they not be consolidated because this Court purportedly lacks jurisdiction over both appeals. However, Appellees have provided this Court with no reason as to why their belief that this Court lacks jurisdiction over these appeals should prevent their consolidation, given that consolidating these appeals would not prevent Appellees from challenging the jurisdictional basis of either or both appeals, whether by motion or in their briefs.

Additionally, this Court notes that the instant appeals are interlocutory, and thus subject

to mandatory expedited treatment. See 4 V.I.C. § 33(d)(5); V.I.S.CT.R. 6(b). As such, this Court shall also issue an expedited briefing schedule in this matter. Accordingly, it is hereby

ORDERED that the motion to consolidate is **GRANTED** and that the motion to vacate the scheduling order is **GRANTED**. It is further

ORDERED that S. Ct. Civ. Nos. 2015-0001 and 2015-0009 shall be CONSOLIDATED as S. Ct. Civ. No. 2015-0001. It is further

ORDERED that, since a cross-appeal has been filed by Appellee Mohammed Hamed as part of S. Ct. Civ. No. 2015-0009, for purposes of the Rules of Appellate Procedure, Fathi Yusuf, having filed his notices of appeal first, **SHALL BE DESIGNATED** as the appellant in this matter, while all other parties to the Superior Court proceedings who wish to participate in this appeal **SHALL BE DESIGNATED** as the appellees. Appellee Mohammed Hamed may brief the issues relevant to his cross-appeal as part of his Appellee's Brief. It is further

ORDERED that the instant appeals are EXPEDITED and that the following SHALL CONSTITUTE the expedited briefing schedule:

- Appellant SHALL FILE its brief and the joint appendix on or before 3:00 p.m. on Friday February 27, 2015;
- Appellees SHALL FILE their briefs on or before 3:00 p.m. on Friday, March 6, 2015;
- Appellant MAY FILE a reply brief on or before 3:00 p.m. on Monday March 9, 2015;
- Appellee Mohammed Hamed MAY FILE a sur-reply brief, which shall be limited solely to the issues he has raised as part of his cross-appeal, on or before 3:00 p.m. on Wednesday March 11, 2015; and it is further
