## MOHAMMAD HAMED'S RESPONSE TO COURT'S INQUIRY RE CONSOLIDATION

While Mohammad Hamed is not a party to this litigation, this Court allowed him to file a brief response to this Court's inquiry reconsolidation.

Counsel for Mohammad Hamed has reviewed the pleadings filed in this case. The existing Complaint has resulted in motions being filed that address specific issues related to (1) the April 30, 2014, Plessen Board Meeting and (2) the Plessen-KAC357, Inc. lease. However, Judge Brady has issued extensive rulings on both issues. Thus, the fact that the Plaintiffs are attempting to re-litigate these same issues in this case supports consolidation with the pending case before Judge Brady, where these issues have already been addressed and resolved (*Hamed v Yusuf*, STX-2012-cv-370).

The new proposed Amended Complaint has the same problem, but enhances it, as it seeks relief on claims alleged against Mohammad Hamed and Plessen

Enterprises, Inc., which the new proposed Plaintiffs have already been asserted in the pending case before Judge Brady. Thus, that factor further supports consolidation.
