STIPULATED SCHEDULING ORDER

ORDERED that the discovery schedule and case deadlines are as follows:

1. INITIAL DISCLOSURES

The parties shall exchange their initial disclosures required by Fed. R. Civ. P. 26(a)(1) by **February 29, 2016..**

2. FACTUAL DISCOVERY

All written discovery shall be propounded by **March 20,, 2016** and all fact depositions shall be completed by September 30,, **2016.**

3. MEDIATION

Mediation shall be completed no later than **October 30, 2016.**

4. EXPERT REPORTS

Each party will file expert disclosures pursuant to Fed. R. Civ. P. 26(a)(2) on any issue in which they have the affirmative burden of proof shall be submitted by **November 30, 2016, .**

5. RESPONSIVE EXPERT REPORTS

Responsive expert reports shall be submitted by **January 11, 2017.**

6. STATUS CONFERENCE

A Status Conference shall be held on _____ **2016.**

6. EXPERT DEPOSITIONS

Depositions of experts shall be completed by **February 15, 2017.**

7. MOTIONS

All dispositive motions and *Daubert* motions shall be filed by **April 1, 2017.** Any and all responses shall be filed in accordance with the applicable rules.

8. PRETRIAL BRIEFS AND ORDER

The parties shall file a Joint Final Pretrial Order and trial briefs and written requests for charge to the jury in accordance no later than **May 15, 2017.**

All motions in *limine*, except those raised by the Joint Final Pretrial Order, voir dire, jury instructions, and proposed jury verdict form, shall be filed no later than **May 15, 2017.**
