**ORDER DENYING MOTION TO CONSOLIDATE**


THIS MATTER is before the Court Defendant/Counterclaimant Fathi Yusuf's Motion to Consolidate Cases (Motion),<sup>1</sup> filed March 17, 2016.

By Order dated August 5, 2016, entered in Case No. SX-13-CV-003, the Court dismissed United Corporation's Complaint against Waleed Hamed, noting that United's claims were duplicative of claims already being litigated in this case. As Case No. SX-13-CV-003 has been dismissed, Yusuf's Motion to Consolidate Case No. SX-13-CV-003 will be denied as moot


In light of the foregoing, it is hereby

<sup>1</sup> On March 17, 2016, Yusuf filed three motions entitled Motion to Consolidate Cases seeking to consolidate this action with three separate cases—*United Corporation v. Waleed Hamed* (SX-13-CV-003), *United Corporation v. Waheed Hamed* (ST-13-CV-001) and *United Corporation v. Wadda Charriez* (SX-13-CV-152). Responses in opposition to were filed, as follows: on March 30, 2016 (Wadda Charriez's Opposition in SX-13-CV-152), on April 1, 2016 (Waheed Hamed's Opposition in ST-13-CV-001), and an identical filing on April 4, 2016 by Waheed Hamed (in ST-13-CV-001). The Court herein denies Yusuf's Motion to consolidate Case No. SX-13-CV-003 with this case, and defers ruling on Yusuf's remaining two motions to consolidate.
