ORDER RE DISCOVERY

This matter comes before the Court on: 1) Plaintiff's Motion for Further Instructions and for an Interim Discovery Scheduling Order, filed October 28, 2016; 2) Defendants' Response thereto, filed November 10, 2016; and 3) Plaintiff's Reply thereto, filed November 16, 2016.

On October 7, 2014, the Court stayed discovery in this matter. By way of several Memorandum Opinions and Orders entered contemporaneously herewith, the Court resolves the various pending disputes between the parties which have, until now, prevented this litigation from moving forward. As such, the Court now directs the Master to proceed toward completion of the Final Wind Up Plan, with full authority to establish and enforce a plan for conducting further discovery in this matter and to hear and resolve all disputes related thereto, subject to review by the Court only for abuse of discretion pursuant to Virgin Islands Rule of Civil Procedure 53(f)(5). Additionally, the parties shall be responsible

for working with the Master to design and implement a system for docketing and retaining records of all filings submitted to the Master.

Accordingly, it is hereby

ORDERED that Plaintiff's Motion for Further Instructions and for an Interim Discovery Scheduling Order is GRANTED, in part. It is further

ORDERED that the Court's Order of October 7, 2014 staying discovery is VACATED. It is further


ORDERED that the Master is empowered to establish and enforce a plan for conducting further discovery in this matter and to hear and resolve all disputes related thereto. It is further
