**HAMED'S MOTION TO EXCEED THE RULE 6.1(E)(2) LIMITATIONS BY 3 PAGES
AS TO HIS REPLY REGARDING HIS MOTION FOR SUMMARY JUDGMENT
RE PARTIAL SUMMARY JUDGMENT FOR CLAIM H-142 (TUTU PARCEL)**

This motion asks the Master to allow enlargement of the page length and word count limits on Hamed's REPLY as to his motion for summary judgment *on Claim H-142*, regarding the 0.536 acre parcel near Tutu Park Mall on St. Thomas. The applicable rule is *V.I. Rule of Civil Procedure 6-1(e)(2)* which provides:

(2) Except as provided in Rule 56-1, all motions, responses and replies filed with the court shall not exceed the greater of 20 pages or 6,500 words in length unless leave of court has been obtained in advance for a longer submission. This page or word limit does not include any cover page, caption, table of contents, table of authorities, appendices or exhibits, and certificates of service. . . .

The Reply contains many quotes of Yusuf's Opposition and restatements of the headings below—to provide easier context for the discussion. To avoid the delay and confusion for the reader, of placing these in exhibits, Hamed has left them in, and exceeded the limits under the rule.

Should the Master or Opposing Counsel object, a revised copy with those headings and quotes as exhibits will be submitted.
