Dear Attorney Hartmann:

I am writing in connection with the Motion you have filed to amend the Complaint in this case to add Manal Yousuf as a named party defendant. I will not consent to the filing of this motion to amend, or to the amendment itself. It is my belief that this pleading is not only completely barred by the applicable Statute of Limitations, but also is contrary to the provisions of Rule 11(b)(1-5), I request that this motion be withdrawn.

Your motion to amend alleges that the Note and Mortgage given to Manal by Sixteen Plus was a sham. If so, this sham took place at the time the Note and Mortgage were executed and delivered, now more than twenty-five (25) years ago.
