JOINT NOTICE RE STATUS OF CLAIMS

Introduction

On August 30, 2023, the Special Master required the parties to provide a joint notice "advising the Master of the outstanding claims and the expected timeline for the resolution of such claims."

The parties have conferred and counsel for Yusuf has agreed to have the following joint response submitted by undersigned counsel.

1. Outstanding Claims

All of the outstanding claims are set forth in the attached chart – the spreadsheet supplied to all parties and the Master's Clerk on a roughly monthly basis. **Exhibit A.**

Yusuf believes there are two Yusuf "B" claims remaining. Yusuf asks that he be allowed to submit these by November 1, 2023.

Hamed believes there are no Hamed "B" claims remaining which Hamed will pursue.

With regard to the "A" (Gaffney reviewed) claims, the spreadsheet reveals 67 outstanding claims – marked in the leftmost "GAF" column with a "1". Mr. Gaffney has asserted that he again has time to work on these—and if the Special Master wishes, the parties will obtain and submit a more detailed statement by Mr. Gaffney with his estimates.

2. Timeline

With the submission of the final two filings by Yusuf on November 1st, it is expected the "B" claims will be completed by the end of the year or shortly thereafter. The "A" claims are a function of Mr. Gaffney's ability to proceed as described above.
