

Yusuf, et al., Civil Case Number SX-2016-CV-650 (hereinafter "650 Case"), and Yousef v. Sixteen Plus Corp., Civil Case Number SX-2017-CV-342 (hereinafter "342 Case")—whereby the Court appointed the undersigned as the special master in these consolidated cases to address all pretrial matters and any other matters agreed upon by the parties. (Aug. 10, 2023 Order.)

THIS MATTER came before the Special Master (hereinafter "Master") on Carl J. Hartmann III, Esq.'s (hereinafter "Attorney Hartmann") July 9, 2024 motion to withdraw—filed in the 650 Case—as co-counsel of Plaintiff Hisham Hamed, individually and derivatively on behalf of Sixteen Plus Corporation effective October 1, 2024; July 9, 2024 motion to withdraw—filed in the 065 Case—as co-counsel of Plaintiff/Counter-Defendant Sixteen Plus Corporation effective October 1, 2024; and July 9, 2024 motion to withdraw—filed in the 342 Case—as co-counsel of Defendant/Counter-Plaintiff/Third-Party Plaintiff Sixteen Plus Corporation effective October 1, 2024. Attorney Hartmann filed two separate declarations—in the 650 Case—in support of his motion. Having been advised of the premises, the Master will grant Attorney Hartmann's motions to withdraw as co-counsel. Joel H. Holt, Esq. of Law Office of Joel H. Holt remains as counsel for Hisham Hamed in the 650 Case and as counsel for Sixteen Plus Corporation in the 065 Case and the 342 Case. Accordingly, it is hereby:

ORDERED that Attorney Hartmann's July 9, 2024 motion to withdraw—filed in the 650 Case—as co-counsel of Hisham Hamed effective October 1, 2024; July 9, 2024 motion to withdraw—filed in the 065 Case—as co-counsel of Sixteen Plus Corporation effective October 1, 2024; and July 9, 2024 motion to withdraw—filed in the 342 Case—as co-counsel of Sixteen Plus Corporation effective October 1, 2024 are **GRANTED**. And it is further:

ORDERED that Attorney Hartmann shall be **WITHDRAWN** as co-counsel for Hisham Hamed in the 650 Case and as co-counsel for Sixteen Plus Corporation in the 065 Case and the 342 Case, effective October 1, 2024, without any further action from the Master or the Court.
