**STIPULATED SCHEDULING ORDER**


The parties, by and through their counsel, hereby agree as follows:

1. **INITIAL DISCLOSURES.** The Parties shall mutually exchange their Initial Disclosures pursuant to V.I.R.Civ.P. 26(a)(1) no later than May 31, 2017.
2. **FACTUAL DISCOVERY.** All factual discovery, including, written discovery and fact witness depositions, shall be completed by December 15, 2017.
3. **MEDIATION.** Mediation shall be completed no later than December 31, 2017.
4. **PLAINTIFF'S EXPERT REPORTS.** Plaintiff's expert disclosures, pursuant to V.I.R.Civ.P. 26(a)(2), if any, shall be submitted by January 15, 2018.
5. **DEFENDANT'S EXPERT REPORTS.** Defendant's expert disclosures pursuant to V.I.R.Civ.P. 26(a)(2), if any, shall be submitted by February 28, 2018.
6. **EXPERT DEPOSITIONS.** Depositions of experts shall be completed by March 31, 2018.
7. **DISPOSITIVE MOTIONS.** All dispositive motions shall be filed no later than April 30, 2018.
8. **TELEPHONIC STATUS CONFERENCE.** A **TELEPHONIC** status conference shall be held on August 23, 2018 between 9:00 a.m. and 12:00 p.m.

9. TRIAL DATE. Trial will be scheduled by the Court. The earliest date by which the parties should be ready for trial is July 15, 2018.


