## ORDER DISMISSING DEFENDANT ST. CROIX RENAISSANCE GROUP, LLLP (SCRG)

This matter is before the Court on defendant St. Croix Renaissance Group, LLLP's Corrected Notice of Filing Stipulations to Dismiss SCRG as a Defendant in 220 of the 221 Red Mud Cases, filed on July 7, 2023. Plaintiffs did not oppose the motion. The attached exhibit indicates the individual cases being dismissed. The premises considered, it is hereby

ORDERED that defendant SCRG is DISMISSED WITH PREJUDICE from all cases listed on the attached Exhibit A, grouped under the above-referenced master case with each party to bear their own fees and costs.

ORDERED that this dismissal is without prejudice to any claims the remaining defendant in Abraham v. SCRG et al. CIVIL NO. SX-2011-CV-00550, Alcoa, Inc. n/k/a Howmet Aerospace, Inc. may have against SCRG.


